

### **INTRODUCTION:**

The present invention is an ice-machine rotatable assembly and housing which could be used to produce ice for various uses. One of the advantages of this invention is that the splasher assembly can be easily removed from splasher-type ice-machines






### **BACKGROUND OF THE INVENTION:**

- A typical way commercial high output ice making machines ("ice machines") work is by use of rotating arm(s) to move water on to a refrigerated surface to form ice.
- The arm or arms are configured to splash water against a cooled evaporator and ice former
- A disadvantage of such splasher-type ice-machines and some other machines with rotatable members is that it is
  often difficult to remove the rotatable member assembly for cleaning, repair and/or replacement.
- This invention essentially works by using the rotating arms to move a liquid toward an ice former, where the rotating arms can be easily removed


### **ABOUT THE INVENTION:**

The rotating arms can be easily pulled out for easy removal of the complete Splasher Assembly for cleaning, maintenance or replacement.

#### ICE MAKING MACHINES AND USEFULNESS OF PRESENT INVENTION

- An Ice Making Machine typically works on the same principle as a refrigerator (refrigeration cycle) and includes standardized components such as compressor, condenser, evaporator, throttle valves
  - Compressor compresses low-pressure refrigerant vapour to high-pressure vapour and fed to condenser. Condenser converts high-pressure vapour into high-pressure liquid which drains out through the throttle valve to become low-pressure liquid. At this point, the liquid is conducted to the evaporator, where heat exchanging occurs, and ice is created.
  - Evaporator is an important component, where the actual ice formation happens. Typically, water is drawn and continuously flown or poured over the Evaporator gradually freezing the water and building up ice cubes
  - The ice cube making machines rely on water becoming ice at freezing point of ice (0 degree Celsius or 32 degrees Fahrenheit)
- For this freezing action, it is therefore of utmost importance, that the water and the whole ice making system remains pure, free of impurities
- The present invention scores a major point over other ice making machines, by having an easy Slide Out Design allows for easy removal of the rotating arms of the Splasher Assembly for easy cleaning, maintenance and replacement
